

# Data Steward Certification

## Industry-recognized certification for experienced Collibra Data Stewards

Collibra is a single source of truth for diverse teams to discover, understand and trust data. By implementing data governance processes across the organization, data citizens can confidently make strategic, informed and data-driven decisions based on high-quality, compliant data.

### Who should get certified?

This certification is for those who use a shared language to foster transparent collaboration with stakeholders in a central location.

Those responsible for:

#### Asset management

- Enrich assets within Collibra with features such as data classification and the AI description generator
- Create and maintain relationships between data assets within Collibra's Data Dictionary and Business Glossary
- Complete assigned tasks to progress assets through their lifecycle
- Maintain accurate and up-to-date metadata for assigned assets

#### Data governance

- Contribute to the development and documentation of data governance policies, standards and procedures
- Ensure adherence to data governance policies and standards for assigned data assets
- Act as a liaison between business users, IT and data teams to address data-related issues and questions

#### Collibra Platform management

- Test and validate Collibra updates and new features
- Identify opportunities to improve the efficiency and effectiveness of the Collibra

#### Collaboration and communication

- Collaborate with data owners, business users and IT teams to understand data requirements and ensure data quality
- Participate in data governance working groups and committees
- Communicate data governance policies and standards to stakeholders

## Who's eligible?

- 3+ months of experience with the Collibra Platform
- Strong foundation of data governance principles and best practices

## Exam details

During the exam, the test taker will:

- Provide a government-issued ID to verify their identity
- Have 2 hours to complete approximately 60 multiple-choice questions
- Be proctored and recorded through Certiverse, our trusted certification vendor
- Use a lock-down browser provided by Certiverse that limits computer/software access


## What does the exam cover?

The exam covers eight domains, each with associated tasks.

### Exam cost

The exam costs \$125 USD, paid via credit card.

Premium Education membership includes two exam attempts.



### Asset evaluation

- Describe the asset lifecycle and how it relates to articulation scoring
- Interpret validation results
- Interpret data profiling results
- Describe an articulation score
- Ensure data sets meet certification standards
- Analyze data flow with the technical lineage viewer

### Asset management

- Create assets
- Enrich an asset by adding new information about it
- Create relations between assets
- Make an ingested catalog asset (e.g., a Report) more valuable by adding more context
- Improve understanding of ingested catalog assets (e.g., Report Attributes) by linking them to business terms
- Create asset descriptions using Collibra's AI description generator
- Use search filters to find assets
- Identify domain type based on asset type
- Resolve issues for assets that have since been modified in the data source
- Create or modify data sets based on defined requirements

### Data classification

- Review ingested data and data classes
- Accept or reject Edge-suggested data classifications on columns
- Configure data classification thresholds

### Asset views

- Use filters to create a new view with specific assets
- Create a new view using hierarchy paths and filters with AND/OR logic

### Collaboration

- Rate, comment and ask a question about an asset
- Complete tasks
- Resolve asset issues or answer comments
- Run and participate in approval workflows
- Reassign tasks

### Import/export

- Export assets and their characteristics
- Use a spreadsheet import to update attributes and relations in bulk
- Handle import errors

### Diagrams

- Trace business lineage
- Build diagrams
- Create and edit a diagram view

## Preparing for success

Those interested in this certification are strongly encouraged to take hands-on training in preparation for the exam. You can complete this through Collibra's Data Steward Virtual Lab or instructor-led training.
